1. Set up can begin as early as 7:30 a.m., but **MUST** be completed by 9:30 a.m. If you have a pre-assigned space, you **MUST** be in your space by 8:00 a.m. or it will be given away. For rain date info, call the nursery school @ 201-447-6232 after 6:00 a.m. on the day of the Fall Festival.
2. The **NON-REFUNDABLE FEE** is \$75.00 seventy-five dollars (U.S) per space, or \$125.00 one hundred twenty-five dollars (U.S.) for a double space. A space is determined by the length of your vehicle. Dealers will be parked as they arrive (for dealers without assigned spaces). The set-up (tables, chairs and wares) will be parallel to the length of the vehicle and are the responsibility of the vendor. Checks should be made payable to: COOPERATIVE NURSERY SCHOOL OF RIDGEWOOD.
3. Kindly choose 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> choices from map. Repeat vendors can choose the space they had last year, provided a contract is received by July 15, 2009.
4. A permit, space number and directions will be mailed to you after September 1, 2009 and must be presented for entrance. Applications received after September 17, 2009 will be confirmed by telephone and your permit can be claimed at the entrance on the day of the Festival. Permit entitles dealers to a FREE cup of coffee.
5. There will be **ABSOLUTELY NO VEHICULAR TRAFFIC** within the selling area during open hours between 10 a.m. and 4:30 p.m. Anyone not willing to remain in the lot until after 4:30 p.m. may unload at his/her designated space prior to 9:30 a.m. and park in the adjacent lot.
6. Each participant is responsible for the cleanup of his/her assigned space. Vendors are responsible for the removal of their own empty boxes. Please leave the area as clean as you found it.
7. The Cooperative Nursery School of Ridgewood United Methodist Church is not responsible for damage to, or loss of merchandise, and the vendor agrees not to hold the school liable.
8. **\*\*\*NO FOOD** concessions are permitted. Anyone selling any type of pre-packaged food is responsible for contacting the Ridgewood Health Dept. @ 201-670-5554 and obtaining a one day special event license. Refreshments will be available all day, and rest rooms are on the premises. Also, **NO FIREWORKS, SNAPPERS, BOMB BAGS, CAP GUNS OR SILLY STRING** of any kind may be sold.
